You will not often see Consulting Foresters advertise in local papers. Most are very busy. This is not an all-inclusive list. There are foresters working the region do not want on the list due to existing extensive work loads.

Forestry Services provided by Consulting Foresters includes, but is not limited to:

- 1. Writing Forest Management Plans for the property tax reduction programs and cost share programs available to landowners.
- 2. Conducting managed timber sales where the trees to be cut are individually marked, measured, and presented to multiple buyers for bid. Foresters then oversee the sale to insure contract compliance.

- 3. Evaluate timber for timber tax cost basis. Establishing a basis reduces taxes when timber is sold.
- 4. Marking of "Release Thinning". Foresters will identify which trees need to be killed in the woodland to improve quality, growth, and wildlife habitat.
